

CONTRACT FOR PROVISION OF STUDENTS TRANSPORTATION SERVICES

This contract is executed on this 10 Th day of July 2016 between the Sunrise English private School

Whose address is P.O.No.71356 Musaffah, Abu Dhabi, United Arab Emirates, herein after referred to as "SCHOOL "represented by Dr. Thakur S. Mulchandani, on one part.

AND

Fast Rent A Car whose address is P.O.Box No. 6365, Abu Dhabi ,united Arab Emirates , herein after referred to as the"CONTRACTOR"represented by General Manager, Mr. Karunesh Arya

On the other part.

WITNESSTH

Whereas the SCHOOL desires to have the **CONTRACTOR** to execute this contract with **41** new buses with ADEC specification to provide the students transportation services to and from the **SCHOOL** herein after more fully described and set forth in schedule -1 hereto ;and

Whereas the **CONTRACTOR** represents that they have the required personnel and the new vehicles to perform the services, in accordance with the terms and conditions set forth herein, and desires to perform such services for the **SCHOOL**.

Now therefore, in consideration of the services charges and the covenants herein after set forth the **SCHOOL** and the **CONTACTOR** hereby agree as follows:

Any reference to "the contract" is reference to the original contract and to any renewal or extension thereafter.

ARTICLE 1

1.1 the period of the contract is hereby confirmed for 5 (five) years effective from 28th August 2016
Unless terminated.

ARTICLE 2

2.1 DESCRIPTION OF SERVICES:

The **CONTRACTOR** shall in accordance with the terms and provisions of this contract provide at its sole cost and expenses 41 numbers of buses and drivers required for performance of the services as described in schedule 1: The **SCHOOL** shall provide a bus nanny for each bus in order to take care of the students travelling in it at its own cost.

2.2 STANDARDS:

The **CONTRACTOR** and its employees shall discharge their duties under this contact in a safe and workman like manner in accordance with the standard practices of the business.

ARTICLE 3

3.1 INDEPENDENT CONTRACTOR:

The **CONTRACTOR** is an independent contractor for all purpose of this contract and all persons, vehicles and equipment engaged in performance of the service shall be under the complete direction and control of the **CONTRACTOR**.

3.2 THIRD PARTIES RELATIONSHIP:

All contractual obligations taken by the **CONTRACTOR** with third parties in connection with the services shall be in the name of the **CONTRACTOR**, and with no obligation on part of the **SCHOOL**

ARTICLE 4

4.1 EMPLOYEE'S REMUNERATION:

The **CONTRACTOR** shall be responsible for the payment of all salaries, wages and related benefits applicable to its employees.

ARTICLE 5

5.1 SCHOOL REPRESENTATIVE:

The **SCHOOL** shall designate and keep assigned during the term of this contract a representative herein referred to as the **SCHOOL'S REPRESENTATIVE**, who shall at all times have full charge of the operations of the **SCHOOL** in connection with this contract and shall have the full authority to represent the **SCHOOL** in all matters concerning performance of the services. **SCHOOL** shall always have the right to replace its representative and shall promptly advise the **CONTRACTOR** in writing of the name of any person subsequently appointed.

5.2 CONTRACTOR'S REPRESENTATIVE:

The **CONTRACTOR** shall designate during the term of this contract a representative herein referred to as the **CONTRACTOR'S REPRESENTATIVE**, who shall at all times have full charge of the operations of the **CONTRACTOR** in connection with this contract and shall have the full authority to represent the **CONTRACTOR** in all matters concerning performance of the services, **CONTRACTOR** shall always have the right to replace its representative and shall promptly advise the **SCHOOL** in writing of the name of any person subsequently appointed.

ARTICLE 6

6.1 CONSIDERATION:

A) In consideration of the services rendered under the contract **CONTRACTOR** shall collect from student's parents directly the agreed fees in accordance to the rates and prices as set forth in schedule 2.

B) As the buses are operating 5 days/week for 10 month the **SCHOOL** may request and the **CONTRACTOR** to provide additional trips within Abu Dhabi. The 58 seater bus will be charged at the rate of AED 150/ for 8 hours and the 34 seater bus at AED 100/ 8 hours. If such trips exceed 8 hours an overtime of AED 20/hour should be paid.

Trips to Dubai /Ras al-Khaimah using Fleet buses are to be charged at the rate of 1400 AED for 58 seater buses and AED 750 for the 34 seater buses. All for 8 hours and any excessive hours shall be charged o/time at AED 20/hour.

C) in case **SCHOOL** needs additional buses apart from the contracted 41 buses and /or revised requirements, the pricing and other terms and conditions shall be decided on mutual agreement, and incase requesting the same bus with the same year model and specification the price will be the same as per the agreement if the bus is available with dealer.

ARTICLE 7

7.1 PAYMENT:

The **CONTRACTOR** will collect the fee of AED 3,500 / Year / student for Mussafah sector and AED 4,000/ Year for all other areas from the parents directly.

ARTICLE 8

8.1 MINIMUM INSURANCE REQUIREMENT:

The **CONTRACTOR** shall at all times during the term of this contract carry and maintain in force at its own expense, comprehensive motor insurance policy. The passengers are covered on third party policy subject to the decision of the court.

8.2 LIABILITY LIMITED BY INSURANCE :

The requirements provided herein for insurance coverage is to be carried and maintained in force by the **CONTRACTOR** and shall serve to limit and relieve the **CONTRACTOR** from all other obligations.

ARTICLE 9

9.1 CONFIDENTIALITY

The **CONTRACTOR** and **SCHOOL** shall maintain in strict confidence and shall not use it except for the purpose of this contract, all information concerning the service and the operations and activities of each other.

ARTICLE 10

10.1 NOTICES

All notices required to be given under the provisions of this contract shall be given in writing and shall be sent to other party at the address set forth in the preamble of this contract.

ARTICLE 11

11.1 GENERAL

This contract shall constitute the entire agreement between the parties with respect to the services which cancels and supersedes all the prior negotiations, representations and agreement whether written or oral .no changes or alterations may be made in the terms and provisions of this contract unless amended and agreed in writing by both parties and such amendments hereto shall be effective only when signed by persons authorized by or on behalf of each of the parties below.

In considerations thereof, **SCHOOL** and the **CONTRACTOR** have executed this contract on the day and year written first herein.

SCHEDULE 1

THE SERVICES

The **CONTRACTOR** shall provide transportation of students to and from the **SCHOOL**

Facility as follows:

1. 24 numbers of air – conditioned 58 seater Ashok Leland Falcon buses of 2016 model and 17 numbers of A/C 34 seater Mitsubishi Rosa buses, all modified to ADEC specifications and uniformed drivers to collect the student from the respective locations and drop them in the **SCHOOL** in Musaffah in the morning and collect them from **SCHOOL** in Musaffah and drop them in respective locations in the evening (all buses will do one round trip per day, 11 buses will do two trips and 12 buses will do three round trips per day).
2. In case of breakdown or defects, the **CONTRACTOR** shall provide immediately the substitute bus or buses at no cost to the **SCHOOL**.
3. All 41 buses are fully equipped with ADEC specifications.
4. The buses maintenance will be done on off days only.
5. The **CONTRACTOR** will provide buses in case there are school trips within or outside Abu Dhabi.
6. The **CONTRACTOR** will arrange and provide Smart Tracking System at its own cost.
7. Each bus will have a log book for service , and there will be regular maintenance for the buses (especially tires)
8. All buses will always be kept clean from outside & inside.
9. All Buses will be registered in name of Al Mashreq Al Arabi Bus Rental or Fast Line Bus Rental L.L.C

This schedule is an integral part of the contract for transportation services signed by SUNRISE ENGLISH PRIVATE SCHOOL Musaffah Abu Dhabi and FAST RENT A CAR on day of August 2016.
