Definitions

Additional Learning Needs

Individual requirements for additional support, modifications, or accommodations within a school setting on a permanent or temporary basis in response to a specific context. This applies to any support required by students of determination and those who have special educational needs and/or additional barriers to learning, access, or interaction in that specific context (e.g., dyslexic, hearing or visually impaired, twice exceptional, or gifted and/or talented).

For example, a student with restricted mobility may require lesson accommodations to participate in Physical Education and building accommodations to access facilities but may not require any accommodations in assessments. Equally, a student with hearing impairment may require adaptive and assistive technology to access content in class and may also require physical accommodations (e.g., sit in the front of the class to be able to lip read) to access learning.

Student Performance Reports Refers to any reports or report cards such as school reports, end of year reports or student report cards, which communicate information about the student's holistic progress and achievement.

 - d. Learning goals/recommendations for improvement.
 - e. Participation and achievements in extracurricular activities.
 - f. behavioural records, including details of misconduct.
 - g. Student self-reflection (age appropriate).
 - h. Purpose and methods of assessment.
 - i. A qualitative evaluation of student performance within a curriculum subject or class.
 - j. Others at the school's discretion.
- **2.Grade-Level Templates:** The school has developed and shared grade-level templates of formal school student performance reports with teachers to adopt and effectively communicate student information to parents while incorporating grade-level nuances (e.g. the inclusion of higher education preparation goals for senior students, qualitative feedback along with letter grades for junior students, etc).
